## Possible early or short-term side-effects

Start during radiotherapy or shortly after completing radiotherapy and usually resolve within two to six months of finishing radiotherapy. Frequencies are approximate.

<p><b>Expected</b> 50%–100%</p>	<ul style="list-style-type: none"><li><input type="checkbox"/> Tiredness</li><li><input type="checkbox"/> Skin soreness, redness and itching in the treatment area</li><li><input type="checkbox"/> Red or watery eyes</li><li><input type="checkbox"/> Irritation in the lining of the nose or blocked nose</li><li><input type="checkbox"/> Mouth ulcers</li><li><input type="checkbox"/> Pain in the mouth and/or throat which can cause problems with swallowing</li><li><input type="checkbox"/> Loss or change of taste</li><li><input type="checkbox"/> Hair loss in treatment area</li><li><input type="checkbox"/> Anxiety, low mood, feeling fed-up or poor sleep</li></ul>
<p><b>Common</b> 10%–50%</p>	<ul style="list-style-type: none"><li><input type="checkbox"/> Changes in or loss of smell</li><li><input type="checkbox"/> Temporary hearing loss and/or earache</li><li><input type="checkbox"/> Dry mouth</li><li><input type="checkbox"/> Mouth infections including oral thrush</li><li><input type="checkbox"/> Voice changes</li><li><input type="checkbox"/> Thickened and tenacious secretions</li><li><input type="checkbox"/> Nausea – feeling sick</li><li><input type="checkbox"/> Loss of appetite</li><li><input type="checkbox"/> Weight loss</li><li><input type="checkbox"/> Difficulty swallowing which may require temporary placement of a feeding tube at the start of treatment or during treatment to support nutrition and hydration</li><li><input type="checkbox"/> Risk of hospital admission</li></ul>
<p><b>Less common</b> Less than 10%</p>	<ul style="list-style-type: none"><li><input type="checkbox"/> Chest infection which may be due to food and/or secretions going down the windpipe</li><li><input type="checkbox"/> Dehydration as a result of reduced oral intake</li><li><input type="checkbox"/> Vomiting</li><li><input type="checkbox"/> Lhermitte's sign – temporary changes to the spinal cord presenting as a sudden electric shock like sensation on bending the neck, may occur three to six months after treatment</li></ul>
<p><b>Rare</b> Less than 1%</p>	<ul style="list-style-type: none"><li><input type="checkbox"/> Risk to life</li></ul>

## Possible late or long-term side-effects

May happen many months or years after radiotherapy and may be permanent.  
Frequencies are approximate.

<b>Expected</b> 50%–100% 	<input type="checkbox"/> <b>Skin colour change in the treatment area</b> – usually lighter or darker <input type="checkbox"/> <b>Lymphoedema</b> – skin, chin and soft-tissue swelling
<b>Common</b> 10%–50% 	<input type="checkbox"/> <b>Permanent skin texture changes in treatment area</b> – thicker or thinner skin <input type="checkbox"/> <b>Telangiectasia in the treatment area</b> – small visible blood vessels which look like spidery marks <input type="checkbox"/> <b>Hair loss in the treatment area or patchy re-growth</b> <input type="checkbox"/> <b>Permanent dryness of nose</b> <input type="checkbox"/> <b>Nasal crusting</b> <input type="checkbox"/> <b>Dry mouth</b> <input type="checkbox"/> <b>Altered taste or loss of taste</b> – with possibility of some recovery over 18 months <input type="checkbox"/> <b>Hypothyroidism</b> – under-active thyroid gland, which may require you to take medication <input type="checkbox"/> <b>Cataract</b> – clouding in the lens of the eye, which may require surgery to correct
<b>Less common</b> Less than 10% 	<input type="checkbox"/> <b>Dry eye</b> <input type="checkbox"/> <b>Visual changes and damage to the eye</b> <input type="checkbox"/> <b>Nasal regurgitation/reflux</b> <input type="checkbox"/> <b>Loss of smell</b> <input type="checkbox"/> <b>Hearing loss or hearing changes</b> <input type="checkbox"/> <b>Dental problems</b> <input type="checkbox"/> <b>Trismus</b> – jaw stiffness <input type="checkbox"/> <b>Voice changes</b> <input type="checkbox"/> <b>Swallowing problems</b> – with risk of long-term/permanent feeding tube requirement <input type="checkbox"/> <b>Increased risk of stroke</b> <input type="checkbox"/> <b>Pituitary dysfunction</b> – your pituitary gland not producing enough hormones, this may require you to take medication to replace the hormones <input type="checkbox"/> <b>Osteoradionecrosis of the jaw</b> – damage to the jawbone
<b>Rare</b> Less than 1% 	<input type="checkbox"/> <b>Permanent changes to brainstem, spinal cord and nerves to the face, arm or hand</b> <input type="checkbox"/> <b>Radionecrosis of the brain</b> – damage to a small area of the brain which is not repairable <input type="checkbox"/> <b>A different cancer in the treatment area</b> <input type="checkbox"/> <b>Risk to life</b>

## Statement of patient
