2	Chemotherapy	4	The guidance mentions the proportion of patients having a discussion about palliative chemotherapy and the quality standard measures the proportion receiving chemotherapy. This is a common proxy used, but is not an accurate measure, especially in those diseases where the incident population do not strongly resemble trial populations (due to age and co-morbidities), or where the small benefit of palliative chemotherapy means many patients decline therapy.
